OFFICIAL PROMOTION RULES

The “**Card of the Week**” Promotion (hereinafter the “Promotion”) refers to the events commencing on Sundays beginning on Sunday, August 2nd at 12:01 a.m. and concluding on Sunday, August 30th at 11:59 p.m. (hereinafter the “Promotion Period”) at the ECL Gaming various locations. All references to the time of day contained herein refer to Pacific Standard Time.

Specific Rules

1. Must be at least 21 years of age to participate and participants must provide valid proof of age that is acceptable to ECL Gaming (driver's license, state identification card, or military identification card), which may act in its sole and absolute discretion as it deems appropriate. If Participant is not a U.S. citizen, a current passport or alien registration card is required.
2. Participants must be an ECL Gaming Players Club member. Players Cards are free and are available at any of the ECL Gaming locations.
3. Participants must wager a minimum bet of \$1.25 per hand to qualify.
4. Only a Natural Four of a Kind is eligible for this promotion.

6. Multi-Hand Poker Themes will only be awarded on the baseline winning hand in a single game.
7. Winning hands will receive a display for a multiple-choice award.
8. Random amounts will be awarded based on wagered bets.

 - August 16th – 6s
 - August 23rd – 10s
 - August 30th – 8s
11. The Card of the Week numbers will be posted at each participating ECL Gaming location.
12. Participants are responsible for properly inserting their players card into the slot machine reader for point accumulation. If the slot machine, card reader, or computer system malfunctions, all ratings and/or points may be voided.
13. By participating in this promotion, participants agree to comply with all rules contained herein.
14. No cash equivalent or substitutions of non-cash prizes, except in the sole discretion of ECL Gaming for prizes of comparable value. Prizes are non-transferable.
