ECL GAMING PLAYERS CLUB locations, understand and respect our customers, guests and users' privacy. The Privacy Notice ("Notice") describes how we collect, use, store, share and protect personal information collected from or about ECL GAMING PLAYERS CLUB in connection with ECL GAMING. ECL GAMING PLAYERS CLUB is a loyalty program

for members to gain access to member-only promotions at ECL GAMING, earn and track gaming benefits, and receive exclusive announcements and invitations.

1. PRACTICES COVERED BY THIS NOTICE

This Notice describes our privacy practices in relation to the personal information we collect:

- From individuals who sign up for the ECL GAMING PLAYERS CLUB loyalty program on premises at any ECL GAMING location and use the ECL GAMING PLAYERS CLUB card to participate in our on-property casino gaming activities such as slot machines, promotions and tournaments.
- Through HTML-formatted email message that we sent to you.

The Notice does not apply to the following ECL GAMING entities or services, which are governed by separate privacy notices:

- Wi-Fi Services – When using Wi-Fi services at any of our ECL GAMING locations, the personal information you provide is subject to separate privacy.
- Sweepstakes and Other On-Property Promotions – we will use personal information to allow you to participate in these activities. Some of these activities have additional rules and privacy terms attached to Please refer to each activity's terms and conditions for more information.

2. WHAT PERSONAL INFORMATION WE COLLECT

The personal information we collect may include your name, postal address, email address, phone number, date of birth, driver's license number, photograph, passport number, card payment details, online information, such as your IP address, as well as any other information you choose to provide to us.

Whether you choose to provide any particular information requested by ECL GAMING is completely your own choice. But, if you choose not to provide the information we request, you may be unable to receive or access certain services, offers and information.

Across our properties, ECL GAMING maintains integrated profiles of our customers, in keeping with the highest standards for an exceptional customer service experience. Thus, gaming or other activities tracked by an ECL GAMING PLAYERS CLUB member will be paired with other information we collect from or about that member, in order to personalize your experience and deliver the ECL GAMING PLAYERS CLUB member benefits and opportunities.

3. HOW WE COLLECT INFORMATION

- ***On-Premises Enrollment*** – ECL GAMING PLAYERS CLUB cards are issued and activated on-premises only at ECL GAMING locations, after your identification is collected and verified. We collect your driver's license or other form of government-issued identification when you register for a

ECL GAMING PLAYERS CLUB account by visiting the ECL GAMING PLAYERS CLUB or playing casino games or when requesting a replacement card. We also collect information to register or update your ECL GAMING PLAYERS CLUB account through a mobile device managed by our ECL GAMING staff members including your name, driver's license or government-issued identification, email address, phone number, and we also ask you to create a unique PIN to activate your ECL GAMING PLAYERS CLUB account.

- ***Casino Gaming Activity*** – We collect information about your gaming activity (such as your bets, payouts, winning and game session duration, and all other activities used with your ECL GAMING PLAYERS CLUB card.
- ***Voluntary Information*** – We collect information which you provide to us voluntarily when you communicate directly to us during your use of the Site or our services. This includes information, such as your preference of casino games or ECL GAMING services and amenities, online login information and profile, and information you direct third parties to share with us. Where you choose to self-exclude or self-limit, we will collect your personal information in relation to this
- ***Financial Transactions and Privileges*** – We collect or use your name, email address, phone number, ECL GAMING PLAYERS CLUB account number, member account details, social security number and tax filing information in connection with financial dealings with our casino properties or to administer and service a ECL GAMING PLAYERS CLUB account. We also collect, where applicable, banking information that is necessary to process payments or other transactions, such as withdrawals and deposits or personal checks.
- ***Automatically when you use our Site or services*** – We automatically collect technical information about your online interactions with us (such as IP address and browsing preferences).
- ***CCTV Cameras*** – We use CCTV cameras on our premises that may capture your image.

- **Third parties** – We receive information about you and your interactions with us from third parties, such as marketing and advertising providers, social network services, and data.
- **Public Sources** – We collect personal information that you or the government have made publicly available, such as government entities from which public records are obtained and information you submit in public forums.

4. HOW WE USE YOUR PERSONAL INFORMATION

ECL GAMING uses your information for various purposes, including:

- To provide ECL GAMING PLAYERS CLUB member services, including managing your account, access member-only rates and promotions, earn and track your gaming benefits, process and fulfil orders, allow you to manage your communication preferences and choose how you wish to use your
- To contact you to discuss the services or products you receive from
- To facilitate our casino operations, including to process financially
- If you have chosen to self-limit or self-exclude, to administer self-exclusion program, monitor gaming activity and as required by law.
- To respond to your queries, gaming activity requests or transactions and provide you with related customer service.
- For analytics and profiling purposes, to optimize your experience at ECL GAMING, enhance our marketing, create customer or audience segments (including custom and lookalike audience), enhance our business and operational efficiency and tailor promotions and offers to your preferences and habits when interacting with us.
- To maintain the accuracy of your account or profile information and provide you with a better and more personalize service, including by pairing information collected under this Notice with your ECL Gaming players card account if you have previously visited us.
- To facilitate the provision of transportation services, and other reservations, if these services have been made available to you, upon your request.
- To carry out appropriate compliance, security and/or financial checks, such as when we need to:
 - Confirm your identity;

- Make a payment to you or receive payment from you; and
- Comply with law enforcement, court, and regulatory

5. MARKETING PREFERENCES

- You may withdraw your consent for direct marketing communications at any time by contacting us at promos@eclgaming.com
- When you receive a commercial (promotional) electronic communication, we provide the choice to opt-out of receiving future messages by following the instructions provided in the
- You may choose whether to provide your phone number to receive text messages or advertising phone calls from us or using an automatic telephone dialing system or an artificial or prerecorded voice. By providing your phone number and express consent, you are choosing to receive such messages until you withdraw your consent. Your consent to receive text messages or pre-recorded calls using an automatic telephone dialing system is not required to make a purchase with ECL GAMING. You may revoke your consent at any time by contacting us at promos@eclgaming.com
- Although we do not currently sell, as that term has been defined by the laws of the State of Nevada, your personal information and only share it with third parties who are facilitating the delivery of ECL GAMING services and amenities, if you would like to opt-out of any future sale of your information in the unlikely event we change our practices you can do so by contacting us a promos@eclgaming.com

6. HOW WE SHARE YOUR INFORMATION

- **Marketing Partners** – We share aggregated or de-identified information with our marketing partners to provide certain services, offers and enhance your experience at ECL GAMING This information cannot reasonably be used to identify you.
- **Service Providers** – We disclose your personal information to vendors, consultants and other service providers, such as background check companies, payment processors, marketing companies, email service providers, advertising networks and advertisers, information technology services and those who need access to such information to provide services on our behalf. These companies are prohibited from retaining, using, or disclosing your personal information except as necessary to provide the services on our behalf.

- ***Analytics and Search Engine Providers*** – We share personal information with these providers to assist us in the improvement and optimization of our ECL GAMING PLAYERS CLUB account records,

ECL GAMING PLAYERS CLUB services and provide personal ads to our existing or “lookalike” customer base. Please see the following cookies notice for more information on this:

- ***Compliance and Regulatory Purposes*** – We share your personal information with law enforcement agencies, public authorities or other third parties if legally required to do so, or if we have a good faith belief that such use is reasonably necessary to:
 - Comply with a legal obligation, process or request, such as a subpoena, court order, search warrant or other valid legal process, or to comply with legal or administrative requirements of any governmental authorities, including gaming regulators, tax authorities and law enforcement authorities;
 - Enforce our terms and conditions and other agreements, including investigation of any potential violation thereof;
 - Detect, prevent or otherwise address security, fraud or technical issues; or
 - (In our sole discretion) to protect the rights, property or safety of the ECL GAMING, or any of its corporate affiliates or workforce members, our users and guests, a third party, or the public as required or permitted by law (including without limitation, exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction such as requesting and sharing information with credit bureaus).
- ***Sale or Merger*** – We will also disclose your information to third parties in connection with business transfers or bankruptcy proceedings, as permitted by law:
 - In the event that we sell any business or assets, in which case we will disclose your data to the buyer of such business or assets; or
 - If ECL GAMING is acquired by a third party, in which case information held by us about our users will be one of the transferred assets.
 - Other than to the extent ordered by a court of competent jurisdiction, the use and disclosure of all transferred user information will be subject to this. However, any information you submit or that is collected after this type of transfer may be subject to a new privacy notice adopted by the successor entity.

7. COOKIES AND INTERNET-BASED ADVERTISING

Our website functions are based, in part, on your browser's ability to accept cookie files, web beacons, tracking pixels, and other tracking technologies. Cookies are pieces of information that a website transfers to your hard drive that allow you to more easily navigate a website and customize website features that are updated each time you visit a website. Our web servers may automatically recognize a visitor's domain name (such as .com, .edu, etc.), the web page from which a visitor enters our website, which pages a visitor visit on our website and on certain other websites, and/or how much time a visitor spends on each page. We may contract with third-party service providers to assist us with our site visitors. These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business. We, or third parties, may also use cookies to track you or your online activities over time or across websites. We aggregate this information and use it to evaluate, better understand and improve our website, or to support our advertising practices. 8. MINIMUM AGE REQUIREMENTS

We do not knowingly or intentionally collect any personally identifiable information from, or market to, individuals under the age of 21. Pursuant to law, persons under the age of 21 are not permitted to gamble at our properties or loiter in casino areas. Our online services are not intended for persons under the age of 13. Persons under the age of 13 are not allowed to use our online services in any fashion, so the provisions of the Children's Online Privacy Protection Act do not apply to ECL GAMING online services. If you learn that a child under the age of 13 has provided us with personal information contrary to these rules, please contact us at the address listed in the "Contact Us" section below.

9. PROTECTING YOUR PERSONAL INFORMATION

We implement and maintain reasonable security appropriate to the nature of the personal information that we collect, use, retain, transfer or otherwise process. Our policy is to restrict access to your personal information to only those employees, service providers and other third parties who need to know that information to provide products or services to you. We maintain commercially reasonable physical, electronic and procedural safeguards consistent with industry standards and other applicable standards as required by law and we require service providers and third parties to do the same.

While we are committed to developing, implementing, maintaining, monitoring and updating a reasonable information security program, unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. Data security incidents and breaches can occur due to vulnerabilities, criminal exploits or other factors that cannot reasonably be prevented. Accordingly, while our reasonable security program is designed to manage data security risks and thus help prevent data security incidents and breaches, it cannot be assumed that the occurrence of any given incident or breach results from our failure to implement and maintain reasonable security. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations of the Internet which are beyond our control; (b) the security, integrity, and privacy of any and all information and data exchanged between you and us through the website cannot be guaranteed; and (c) any such information and data may be viewed or tampered with in transit by a third party.

10. RETENTION

We keep your personal information for as long as it is required by us for our legitimate business purposes, to perform our contractual obligations, or where longer, such longer period as is required by law or regulatory obligations which apply to us. Some personal information may be retained after your relationship with us ends.

11. LINKS TO THIRD-PARTY WEBSITES

Our websites may contain links to websites operated and maintained by third parties, over which we have no control. Privacy policies on such linked websites may be different from our Privacy Policy. You access such linked websites at your own risk. You should always read the Privacy Policy of a linked website before disclosing any personal information on such website.

12. POLICY CHANGES

To improve the services we can offer you, ECL GAMING may opt to expand our capabilities for obtaining information, including personal information, about users in the future. ECL GAMING will update this Privacy Policy when necessary to ensure that you are aware of developments in this area.

We will post those changes on our websites and update our Privacy Policy so that you will know what information we collect online, how we use it and what choices you have. Please be sure to check this page before proceeding to use our websites. Regardless of any changes we make to our Privacy Policy, we will always use your personal information in accordance with the version of the Privacy Policy in place at the time you provided your information, unless you give your express consent for us to do otherwise.

13. ADDITIONAL PRIVACY TERMS

In conducting business with ECL GAMING or using our websites, you may be required to agree to additional written or electronic agreements, including additional privacy terms and conditions (“Additional Privacy Terms”), as a condition to visiting the websites or receiving products, services and other information. In the event of any conflict between the Additional Privacy Terms and this Privacy Policy, the Additional Privacy Terms shall prevail but we will treat personal information that you provide to us before we adopt such Additional Privacy Terms in accordance with the terms of this Privacy Policy, unless and until you agree with the application of the Additional Privacy Terms to your personal information collected by us prior to the updates or amendments.

15. CALIFORNIA PRIVACY RIGHTS AND DISCLOSURES

This California Privacy Rights and Disclosure section addresses legal obligations and rights specified in the California Consumer Privacy Act, or CCPA. For the purposes of this section

12 (*California Privacy Rights and Disclosures*), personal information means information that identifies, relates to, describes, is reasonably capable of being associated with, or could be reasonably linked, directly or indirectly, with a particular consumer, device or household.

These obligations and rights apply to businesses doing business in California and to California residents and information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with California consumers or households. It does not include deidentified or aggregate information, or public information lawfully available from governmental records.

The following chart describes the categories of personal information we may have collected about you in the past 12 months and, for each category, where and why we collected it, and the categories of entities with which we share or sell the personal information, if any:

If you are a California resident, the CCPA grants you the right to request certain information about our practices with respect to personal information, subject to certain legal limitations and applicable exceptions. In particular, you can request the following:

B. YOUR RIGHT TO REQUEST THE DELETION OF PERSONAL INFORMATION

Upon your request, subject to certain legal limitations and applicable exceptions we will delete the personal information we have collected about you.

C. YOUR RIGHT TO ASK US NOT TO SELL YOUR PERSONAL INFORMATION

You have the right to ask us not to sell your personal information. You can exercise this right by emailing us at promos@eclgaming.com.

We may ask for your permission to resume sale of your personal information at a later date but will wait at least 12 months from receipt of your request before doing so.

D. OUR SUPPORT FOR THE EXERCISE OF YOUR DATA RIGHTS

We are committed to providing you with control over your personal information. If you exercise any of these rights explained in this section of the Privacy Policy, we will not disadvantage you. You will not be denied or charged different prices or rates for goods or services or provided with a different level or quality of goods or services.

E. NOTICE OF FINANCIAL INCENTIVES

We may offer you an opportunity to participate in a program where you receive coupons, vouchers and other offers that may be used at the ECL Gaming casinos, nearby attractions or for other products and services that may be of interest, in exchange for our sale of your personal information to this marketing company. You may sign up for this program at check in and may withdraw from the program at any time by contacting us at the information below. These offers are reasonably related to the value of your data to ECL GAMING, based on revenue generated by this marketing partnership, in addition to revenue generated from

increased traffic at attractions and activities, in light of the volume of anticipated participation in the coupon program.

F. HOW WE WILL HANDLE A REQUEST TO EXERCISE YOUR RIGHTS

For requests for access or deletion, we will first acknowledge receipt of your request. We will provide a substantive response to your request as soon as we can, generally within 45 days from when we receive your request, although we may be allowed to take longer to process your request under certain circumstances. If we expect your request is going to take us longer than normal to fulfil, we'll let you know.

When you make a request to access or delete your personal information, we will take steps to verify your identity. These steps include asking you for personal information, such as your name, address, email, phone number, or other information we maintain about you. If we are unable to verify your identity to the degree of certainty required, we will not be able to fulfil the request. We will notify you to explain the basis of the denial.

You may also designate an authorized agent to submit requests on your behalf. If you do so, you will be required to verify your identity by providing us with certain personal information as described above. Additionally, we will also require that the agent provide us with either written permission signed by the you to act on your behalf, or a certified copy of Power of Attorney granted under the California Probate Code. We will deny the request if the agent is unable to submit proof that they are authorized to act on your behalf.

G. ADDITIONAL FACTS ABOUT HOW WE SHARE YOUR PERSONAL INFORMATION

We may share your personal information with others, but only in certain limited situations, including: (i) within our corporate group or among our affiliated entities, all of which follow this Privacy Policy or equivalent privacy policies; (ii) with our service providers or other parties who agree to keep your personal information confidential and use it only on behalf of ECL GAMING; and (iii) as otherwise agreed by you. Third parties with whom we share your personal information are bound to comply with similar and equally stringent undertakings of privacy and confidentiality.

In some cases, we may be required to disclose certain personal information to comply with legal or regulatory obligations; to detect and protect against fraud, or any technical or security vulnerabilities; for an investigation or a legal process, such as a court order or subpoena; to respond to an emergency; or otherwise, to protect the rights, property, safety, or security of third parties, visitors to the website, our businesses, or the public. In addition, ECL GAMING may disclose certain personal information to any third party that acquires, or is interested in acquiring, all or part of ECL GAMING's assets or shares, or that succeeds

ECL GAMING in carrying on all or a part of its business, whether by merger, acquisition, reorganization or otherwise.

16. EUROPEAN PRIVACY RIGHTS AND DISCLOSURES

This European Privacy Rights and Disclosure section addresses legal obligations and rights specified in the General Data Protection Regulation, or GDPR. These obligations and rights apply to individuals who are located in the European Economic Area. This section describes the policies and procedures followed by ECL GAMING regarding the collection, use and disclosure of your personal data when you visit the website, or otherwise interact with ECL GAMING. For the purposes of this section 13 (*European Privacy Rights and Disclosures*), personal data means any information relating to an identified or identifiable natural person, either directly or indirectly.

According to the GDPR, ECL GAMING is the controller of your personal data.

A. COLLECTION OF YOUR PERSONAL DATA

When you visit the website, receive services from us or otherwise interact with us, we may collect the following personal data about you: your name, postal address, email address, phone number, loyalty account information, date of birth, driver's license number, photograph, passport number, credit card information, as well as any other information you choose to provide to us.

B. USE OF YOUR PERSONAL DATA

You have the right to object to processing of your personal data where that processing is carried out for our legitimate interest.

C. SHARING YOUR PERSONAL DATA

We may share your personal information with others, but only in certain limited situations, including: (i) within our corporate group or among our affiliated entities, all of which follow this Privacy Policy or equivalent privacy policies; (ii) with our service providers or other parties who agree to keep your personal information confidential and use it only on behalf of ECL GAMING; (iii) with third parties who we may partner with from time to time in order for those parties to send you electronic marketing, where we have received your consent to do so; and (iv) as otherwise agreed by you. Third parties with whom we share your personal information are bound to comply with similar and equally stringent undertakings of privacy and confidentiality.

In some cases, we may be required to disclose certain personal information to comply with legal or regulatory obligations; to detect and protect against fraud, or any technical or

security vulnerabilities; for an investigation or a legal process, such as a court order or subpoena; to respond to an emergency; or otherwise, to protect the rights, property, safety, or security of third parties, visitors to the website, our businesses, or the public. In addition, ECL GAMING may disclose certain personal information to any third party that acquires, or is interested in acquiring, all or part of ECL GAMING's assets or shares, or that succeeds ECL GAMING in carrying on all or a part of its business, whether by merger, acquisition, reorganization or otherwise.

D. INTERNATIONAL TRANSFERS

When you are based in the European Union (the "EU"), personal data collected from you, including via the websites may be transferred to certain recipients located outside the EU, which do not provide a similar or adequate level of protection to that provided by countries in the EU. *You hereby consent to the transfer of your personal data to recipients as described in this Privacy Policy which is located outside of the EU.* You may withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

E. RIGHTS OF INDIVIDUALS

You may have certain data privacy rights which may be subject to limitations and/or restrictions. These rights include the right to: (i) request access to and rectification and erasure of your personal data; (ii) obtain restriction of processing or to object to processing of your personal data; and (iii) ask for a copy of your personal data to be provided to you, or a third party, in a digital format.
