OFFICIAL PROMOTION RULES

The “**Monday Multiplier**” Promotion (hereinafter the “Promotion”) refers to the events commencing on Mondays beginning on Monday, August 3rd at 12:01 a.m. and concluding on Monday, August 31st at 3:59 p.m. (hereinafter the “Promotion Period”) at the ECL Gaming various locations. All references to the time of day contained herein refer to Pacific Standard Time.

Specific Rules

1. Must be at least 21 years of age to participate and participants must provide valid proof of age that is acceptable to ECL Gaming (driver's license, state identification card, or military identification card), which may act in its sole and absolute discretion as it deems appropriate.
